

This material provides mandated reporters with an overview of their obligations and some basic information about the New York State Child Protective Services (CPS) system.

Who Are Mandated Reporters?

New York State recognizes that certain professionals are specially equipped to perform the important role of mandated reporter of child abuse or maltreatment. Those professionals include:

- Hospital personnel engaged in the admission, examination, care or treatment of persons
- * Christian science practitioner
- School official, including (but not limited to):
 - teacher
 - guidance counselor

 - administrator or other school personnel required to hold a teaching or administrative license or certificate

When Am I Mandated to Report?

Mandated reporters are required to report suspected child abuse or maltreatment when they are presented with a reasonable cause to suspect child abuse or maltreatment in a situation where a child, parent, or other person legally responsible for the child is before the mandated reporter when the mandated reporter is acting in his or her official or professional capacity. "Other person legally responsible" refers to a guardian, caretaker, or other person 18 years of age or older who is responsible for the care of the child.

Mandated reporters who are social services workers have expanded reporting requirements. Social services workers are required to report when, in their official or professional role, they are presented with a reasonable cause to suspect child abuse or maltreatment where any person is before the mandated reporter and the mandated reporter is acting in his or her official or professional capacity.

What is a Professional Role?

For example, a doctor examining a child in her practice who has a reasonable suspicion of abuse must report her concern. In contrast, the doctor who witnesses child abuse when riding her bike while off-duty is not mandated to report that abuse. The mandated reporter's legal responsibility to report suspected child abuse or maltreatment ceases when the mandated reporter stops practicing his/her profession. Of course, anyone may report any suspected abuse or maltreatment at any time and is encouraged to do so.

Reasonable Cause to Suspect

Reasonable cause to suspect child abuse or maltreatment means that, based on your rational observations, professional training and experience, you have a suspicion that the parent or other person legally responsible for a child is responsible for harming that child or placing that child in imminent danger of harm. Your suspicion can be as simple as distrusting an explanation for an injury.



What Is Abuse and Maltreatment? Abuse

Abuse encompasses the most serious injuries and/or risk of serious injuries to children by their caregivers. An abused child is one whose parent or other person legally responsible for his or her care inflicts serious physical injury upon the child, creates a substantial risk of serious physical injury, or commits a sex offense against the child. Abuse also includes situations where a parent or other person legally responsible knowingly allows someone else to inflict such harm on a child.

Maltreatment (Includes Neglect)

Maltreatment means that a child's physical, mental or emotional condition has been impaired, or placed in imminent danger of impairment, by the failure of the child's parent or other person legally responsible to exercise a minimum degree of care by:

* failing to provide sufficient food, clothing, shelter, education;

or

- * failing to provide proper supervision, guardianship, or medical care (refers to all medical issues, including dental, optometric, or surgical care); or
- * inflicting excessive corporal punishment, abandoning the child, or misusing alcohol or other drugs to the extent that the child was placed in imminent danger.

Poverty or other financial inability to provide the above is not maltreatment.

Note: The definitions of abuse and maltreatment are different for children in residential facilities operated or licensed by the state.

How Do I Recognize Child Abuse and Maltreatment?

The list that follows contains some common indicators of abuse or maltreatment. This list is not all-inclusive, and some abused or maltreated children may not show any of these symptoms.

Indicators of Physical Abuse Can Include:

- Injuries to the eyes or both sides of the head or body (accidental injuries typically only affect one side of the body);
- * Frequent injuries of any kind (bruises, cuts, and/or burns), especially if the child is unable to provide an adequate explanation of the cause. These may appear in distinctive patterns such as grab marks, human bite marks, cigarette burns, or impressions of other instruments:
- * Destructive, aggressive, or disruptive behavior;
- * Passive, withdrawn, or emotionless behavior;
- * Fear of going home or fear of parent(s).

Indicators of Sexual Abuse Can Include:

- * Symptoms of sexually transmitted diseases;
- * Injury to genital area;
- * Difficulty and/or pain when sitting or walking; Sexually suggestive, inappropriate, or promiscuous behavior or verbalization;
- * Expressing age-inappropriate knowledge of sexual relations;
- * Sexual victimization of other children.

Indicators of Maltreatment Can Include:

- * Obvious malnourishment, listlessness, or fatigue;
- * Stealing or begging for food;
- * Lack of personal care—poor personal hygiene, torn and/or dirty clothes;
- * Untreated need for glasses, dental care, or other medical attention;
- * Frequent absence from or tardiness to school;
- * Child inappropriately left unattended or without supervision.



Where Do I Call to Make a Report?

As soon as you suspect abuse or maltreatment, you must report your concerns by telephone to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR). The SCR is open 24 hours a day, seven days a week, to receive your call. The timeliness of your call is vital to the timeliness of intervention by the local department of social services' Child Protective Services (CPS) unit. You are not required to notify the parents or other persons legally responsible either before or after your call to the SCR. In fact, in some cases, alerting the parent may hinder the local CPS investigation and adversely affect its ability to assess the safety of the children. Oral reports to the SCR from a mandated reporter must be followed within 48 hours by a written report to the local department of social services' CPS unit on form **LDSS-2221A**.

What Happens When I Call the SCR?

There may be times when you have very little information on which to base your suspicion of abuse or maltreatment, but this should not prevent you from calling the SCR. A trained specialist at the SCR will help to determine if the information you are providing can be registered as a report.

The LDSS-2221A Mandated Reporter form can be used to help you organize the identifying or demographic information you have at your disposal. Be sure to ask the SCR specialist for the "Call I.D." assigned to the report you have made.

If the SCR staff does not register the child abuse or maltreatment report, the reason for their decision should be clearly explained to you. You may also request to speak to a supervisor, who can help make determinations in difficult or unusual cases.

Local CPS Role and Responsibilities

When a report is registered at the SCR, the local department of social services is immediately notified for investigation and follow-up. A local CPS caseworker will initiate an investigation within 24 hours.

CPS intervention consists of an evaluation of the child and other children in the home and the development of a plan to meet the needs of the child and family. If there is an immediate threat to the child's life or health, CPS may remove the child from the home.

Upon request, CPS may obtain from the mandated reporter those records that are essential to a full investigation of alleged child abuse and maltreatment for any report made by the mandated reporter. The mandated reporter must determine which records are essential to the full investigation and provide those records to CPS when requested to do so.

Within 60 days of initiating the investigation, CPS will determine whether the report is indicated or unfounded. Mandated reporters may ask to be informed of the outcome of the report.

Law Enforcement Referrals

If a call to the SCR provides information about an immediate threat to a child or a crime committed against a child, but the perpetrator is not a parent or other person legally responsible for the child, the SCR staff will make a Law Enforcement Referral (LER). The relevant information will be recorded and transmitted to the New York State Police Information Network or to the New York City Special Victims Liaison Unit. This is not a CPS report, and local CPS will not be involved.



What Protection or Liability Do I Have? Source Confidentiality

The Social Services Law provides confidentiality for mandated reporters and all sources of child abuse and maltreatment reports. OCFS and local CPS are not permitted to release to the subject of the report any data that would identify the source of a report unless the source has given written permission for them to do so. Information regarding the source of the report may be shared with court officials, police, and district attorneys, but only in certain circumstances.

Immunity from Liability

If a mandated reporter makes a report with earnest concern for the welfare of a child, he or she is immune from any criminal or civil liability that might result. This is referred to as making a report in "good faith."

Protection from Retaliatory Personnel Action

Section 413 of the Social Services Law specifies that no medical or other public or private institution, school, facility or agency shall take any retaliatory personnel action against an employee who made a report to the SCR. Furthermore, no school, school official, child care provider, foster care provider, or mental health facility provider shall impose any conditions, including prior approval or prior notification, upon a member of their staff mandated to report suspected child abuse or maltreatment.

Penalties for Failure to Report

Anyone who is mandated to report suspected child abuse or maltreatment—and fails to do so—could be charged with a Class A misdemeanor and subject to criminal penalties. Further, mandated reporters can be sued in a civil court for monetary damages for any harm caused by the mandated reporter's failure to make a report to the SCR.

Who Provides Training for Mandated Reporters?

The New York State Education Department (SED) Office of the Professions oversees the training requirements for mandated reporters. Some categories—including teachers, many medical professionals, and social workers—need this training as part of their licensing requirement. The training may be included in their formal education program.

The New York State Office of Children and Family Services (OCFS) is proud to be a certified provider authorized by SED to offer mandated reporter training, and has developed a comprehensive curriculum with content customized to medical professionals, educators, law enforcement personnel, day care providers, and human services staff.

OCFS has shared this well-received curriculum with other certified providers of mandated reporter training, as well as with colleges and universities across the state that provide educational programming in the fields covered by the mandated reporter statute.

OCFS provides mandated reporter training through a contractual agreement with the CUNY School of Professional Studies

OCFS offers a Self-Directed Online Training for mandated reporters. This two-hour web-based online training course is available 24/7 and is accessible at:

Special Note: Mandated Reporters who require licensure or certification through the New York State Department of Education (NYSED) are required to take mandated reporter training from a trainer who has been approved by the New York State Education Department. Child Sexual Abuse

What is sexual abuse?

Sexual abuse is a sexual offense against a child, such as rape, sodomy, engaging a child in a sexual activity, or engaging a child in—or promoting a child's—sexual performance.

Touching offenses:

- Fondling
- Touching sexual organs
- Making a child touch an adult sexually
- Attempted or actual sexual intercourse
- Rape

Sexual exploitation:

- Child pornography
- Child prostitution
- Sex rings (this involves one or more adults who abuse children in small groups)
- Ritualistic abuse (sexual abuse as part of a ceremony)

Recognizing sexual abuse

Symptoms of sexual abuse may include physical and behavioral signs. Many children who are sexually abused never exhibit any physical signs. Behavioral signs are more common.

Physical indicators of child sexual abuse:

- Difficulty walking or sitting
- Torn, stained or bloody underclothing
- Pain or itching in the genital area
- Bruises or bleeding in the genital, vaginal or anal area
- Venereal disease
- Pregnancy

Behavioral indicators of child sexual abuse:

- Unwillingness to change for, or participate in, gym class
- Withdrawal from family, school, or friends
- Reverting to more childish or infantile behavior
- Bizarre, sophisticated or unusual sexual behavior or knowledge
- Reports of sexual abuse

Reacting to sexual abuse

In some cases, a child will disclose that he or she has been sexually abused. If a child discloses abuse, try to stay calm and, above all else, believe the child. Children rarely lie about sexual abuse. Here are some other things you should do:

- Allow the child to talk, but don't press. Don't ask the child to repeat the details over and over.
- Praise the child for telling you.
- Reassure the child that he or she is not to blame.
- Show love and respect for the child.
- Protect the child immediately from the suspected offender.

Reporting sexual abuse

If the abuse was by someone in the child's family or household, make a report to the New York State Child Abuse Reporting Hotline at 1-800-342-3720. If you are a mandated reporter, call 1-800-635-1522. The hotline will notify the local Child Protective Services (CPS), who will investigate and take needed action to protect the child.

If the abuse was by someone outside of the family and household, report to the local or state police or sheriff's department.

Myths and facts about child molesters

Knowing who child molesters may be and how they operate can help keep children safe.

The myths: Don't be fooled into thinking all child molesters are:

- Strangers or "dirty old men"
- Homosexuals
- Mentally disabled
- Lurking in alleys, parks and schoolyards
- Drug or alcohol abusers

The facts: A child molester is usually:

- A trusted adult or older teen, often a close friend or family member.
- Someone with access to children, such as a babysitter, neighbor or coach.
- A skillful manipulator, willing to use any trick he or she can, including lavish attention, gifts, force, guilt, lies about the child's family, threats to the child's family, or using child victims to "recruit" new victims.

Most adults are not molesters. Don't teach children to mistrust adults. Teach them about safety and staying alert to unusual adult behavior.











Recognizing Emotional Abuse

Emotional Abuse

Emotional Neglect

Warning Signs

Emotional abuse includes parents' or caretakers' acts or omissions that cause or could cause serious conduct, cognitive, affective, or other mental disorders. For example, torture, close confinement or the constant use of verbally abusive language to harshly criticize and denigrate a child.

It also includes emotional neglect — withholding physical and emotional contact to the detriment of the child's normal emotional development, and in extreme cases, physical development.

The behavior of parents and children can offers clues to what may be occurring in the home. A parent or caregiver may be **emotionally abusing** a child if they routinely:

- Ridicule the child and mock the child's appearance, ideas, abilities, fears or accomplishments.
- Criticize the child and undermine the child's confidence and feelings of self-worth with cruel remarks such as, "You are no good," or "You should have never been born."
- Terrorize the child by yelling repeatedly, threatening to beat or abandon the child, or exposing the child to family violence.
- Reject the child by consistently denying affection or clearly favoring a sibling.
- Humiliate the child or shame the child in front of others as a form of discipline.
- Blame the child without cause or make the child feel responsible for anything that goes wrong.

A parent or caregiver may be **emotionally neglecting** a child if they routinely:

- Fail to show interest in the child's thoughts, feelings, or activities.
- Withhold affection when the child falls short of the parent's unrealistic expectations.
- Fail to express warmth or tenderness to the child.
- Isolate the child and refuse to allow the child to interact with others.

Physical indicators

Emotional maltreatment can be difficult to detect. The following physical and behavioral indicators do not always imply abuse and neglect, but adults should be concerned if a child regularly exhibits several of indicators.

Physical indicators of emotional maltreatment: physical developmental delays, wetting of bed or pants, speech disorders, health problems such as ulcers, asthma, or skin disorders, severe allergies, obesity, extreme weight loss or gain, or poor appearance

Behavioral indicators

Behavioral indicators of emotional maltreatment: habit disorders such as sucking, biting, or rocking, destructive behavior to self and/or others, depression, extremes in behavior, aggressive or withdrawn behavior, phobias, sleep disorders, mental or emotional developmental delays, anti-social behavior such as cruelty, vandalism, stealing, or cheating, learning disorders, inappropriately adult or infantile behavior, suicidal thoughts or actions

Reporting emotional abuse

It may be necessary to file a report of child abuse and neglect with the reporting hotline at the New York State Central Register of Child Abuse and Maltreatment. The number is **1-800-342-3720**. They will notify the local Child Protective Services (CPS), which is part of the county Department of Social Services. The reason to make a report is to get help for the child and the family. CPS will investigate and take needed action to protect the child and to help the parent(s) solve problems which are leading to violence, abuse, and neglect.

Help is available

<u>Abstract of Sections from Article 6, Title 6, Social Services Law</u> Section 412. Definitions

1. **Definition of Child Abuse**, (see also N.Y.S. Family Court Act Section 1012(e))

An "abused child" is a child less than eighteen years of age whose parent or other person legally responsible for his care:

- 1) inflicts or allows to be inflicted upon the child serious physical injury, or
- 2) creates or allows to be created a substantial risk of physical injury, or
- 3) commits sexual abuse against the child or allows sexual abuse to be committed.
- 2. **Definition of Child Maltreatment**, (see also N.Y.S. Family Court Act, Section 1012(f))

A "maltreated child" is a child under eighteen years of age whose physical, mental or emotional condition has been impaired or is in imminent danger of becoming impaired as a result of the failure of his parent or other person legally responsible for his care to exercise a minimum degree of care:

- 1) in supplying the child with adequate food, clothing, shelter, education, medical or surgical care, though financially able to do so or offered financial or other reasonable means to do so; or
- 2) in providing the child with proper supervision or quardianship; or
- by unreasonably inflicting, or allowing to be inflicted, harm or a substantial risk thereof, including the infliction of excessive corporal punishment; or
- 4) by misusing a drug or drugs; or
- 5) by misusing alcoholic beverages to the extent that he loses self-control of his actions; or
- 6) by any other acts of a similarly serious nature requiring the aid of the Family Court; or
- 7) by abandoning the child.

<u>Section 415. Reporting Procedure.</u> Reports of suspected child abuse or maltreatment shall be made immediately by telephone and in writing within 48 hours after such oral report.

<u>Submit the written paper copy of the LDSS-2221A form originally signed to</u>: the Local County Department of Social Services (LDSS) where the abused/maltreated child resides.

Section 419. Immunity from Liability, Pursuant to section 419 of the Social Services Law, any person, official, or institution participating in good faith in the making of a report of suspected child abuse or maltreatment, the taking of photographs, or the removal or keeping of a child pursuant to the relevant provisions of the Social Services Law shall have immunity from any liability, civil or criminal, that might otherwise result by reason of such actions. For the purpose of any proceeding, civil or criminal, the good faith of any such person, official, or institution required to report cases of child abuse or maltreatment shall be presumed, provided such person, official or institution was acting in discharge of their duties and within the scope of their employment, and that such liability did not result from the willful misconduct or gross negligence of such person, official or institution.

Section 420. Penalties for Failure to Report.

- Any person, official, or institution required by this title to report a case of suspected child abuse or maltreatment who willfully fails to do so shall be guilty of a class A misdemeanor.
- 2. Any person, official, or institution required by this title to report a case of suspected child abuse or maltreatment who knowingly and willfully fails to do so shall be civilly liable for the damages proximately caused by such failure.

<u>Abstracto de las Secciones del Artículo 6, Título 6, Ley de Servicios Sociales</u> Sección 412. Definiciones

- Definición de Abuso de Niños (Vea también la Sección 1012(e) del Acta del Tribunal de Familia del Estado de Nueva York).
 Un "niño abusado" es un niño(a) de menos de 18 años de edad cuyo padre/madre u otra persona legalmente responsable por su cuidado:
 - 1) causa o permite que se inflija serios daños o lesiones físicas en el niño(a);
 - 2) cree o permite que se cree un riesgo sustancial de daños o lesiones físicas; o
 - 3) comete abuso sexual contra el niño(a) o permite que se lleve a cabo abuso sexual contra el niño(a).
- 2. <u>Definición de Maltrato Infantil</u> (Vea también la Sección 1012(f) del Acta del Tribunal de Familia del Estado de Nueva York). Un "niño maltratado" es un niño(a) menor de 18 años de edad cuya condición física, mental o emocional ha sido afectada o está en peligro inminente de ser afectada por la falla cometida por su padre/madre u otra persona legalmente responsable por su cuidado de ejercer el mínimo grado de cuidado o atención:
 - 1) en abastecer al niño(a) de comida, vestimenta, albergue, educación y cuidado médico o cirugía adecuada, siendo capaz de hacerlo financieramente o habiéndosele ofrecido medios financieros u otros razonables para hacerlo; o
 - 2) en proveer supervisión o tutoría apropiada al niño(a); o
 - 3) en causar o permitir que se inflija daño o riesgo sustancial de daño no razonable, incluyendo la imposición de castigo corporal; o
 - 4) por el mal uso de drogas; o
 - 5) por el mal uso de bebidas alcohólicas en la medida en que pierdan el control de sus acciones; o
 - 6) por cualquier otro acto similarmente serio que requiera la ayuda del Tribunal de Familia; o
 - 7) por abandono del niño(a).

<u>Sección 415. Procedimiento del Informe.</u> El informe de sospecha de maltrato o abuso de niños debe hacerse inmediatamente por teléfono, y debe hacerse por escrito dentro de las 48 horas de haberse hecho el informe oral.

<u>Sección 419. Inmunidad de Responsabilidad</u> De acuerdo a la Sección 419 de la Ley de Servicios Sociales, cualquier persona, funcionario o institución que participe de buena fe en hacer un informe de sospecha de abuso o maltrato infantil, en la toma de fotografías, o en retirar o mantener a un niño(a) de acuerdo a las provisiones relevantes de la Ley de Servicios Sociales tendrá inmunidad de cualquier responsabilidad civil o criminal que de otra manera se aplicaría por razón de esas acciones. Para propósitos de cualquier procedimiento civil o criminal, la buena fe de tal persona, funcionario o institución bajo mandato de informar casos de abuso o maltrato infantil se presumirá a condición de que tal persona, funcionario o institución haya actuado en ejercicio de sus funciones y dentro del alcance de su trabajo, y que tal responsabilidad no sea el resultado de mala conducta o negligencia intencional de esa persona, funcionario o institución.

Sección 420. Penalidades por la Falla de No Informar

- 1. Cualquier persona, funcionario o institución requerida por este título a informar un caso de sospecha de abuso o maltrato infantil que falle intencionalmente en hacer un informe será culpable de un delito de clase A.
- 2. Cualquier persona, funcionario o institución requerida por este título a informar un caso de sospecha de abuso o maltrato infantil que falle intencionalmente en hacer un informe será responsable civilmente por los daños causados por esa falla.
